I give and bequeath to [my daughter Elizabeth Eve Ellis](#) the following Negroes by name Jack, Louisa and her female child Flora and her two cows and calves. All the remaining part of my personal property to be evenly between my two sons as above named when my son Nathaniel arrives to the age of twenty one years all of the property must be kept together if worked and the monies arising therefrom or as much as necessary must be allocated to the education of my children. Given under my hand this [23rd day of January in the year of our Lord One Thousand Eight Hundred & Seventeen](#). I do appoint my wife Selah Ellis Executrix & my son Jefferson B. Ellis my Executor to the above will.
